Appendix A: Verifying Identity of the Borrower(s)

You are responsible for verifying the identity of the borrower(s) and, if applicable, the guarantor(s) by viewing one piece of Canadian Government-Issued Photo Identification while the individual is in your presence.

Acceptable Identification Documents

Valid, current and authentic original photo identification issued by the Government of Canada or a Canadian Provincial or Territorial Government must be used to verify identity. You must view the original document while in the presence of the individual being verified and confirm that the name and photo on the document match those of the individual.

The photo identification document must:

- Be original
- Be issued by the Government of Canada or the Government of a Province or Territory in Canada
- Indicate the person's name
- Include a photo of the person
- Include a unique identifying number
- Be issued by the competent authority (the Government of Canada or the Government of a Province or Territory in Canada), current (not expired) and valid (unaltered; not counterfeit).
